## CALL FOR NOMINATIONS FOR UBC FACULTY PENSION PLAN ELECTION

This notice is a call for nominations for **TWO** trustees, to be elected by and from the membership of the UBC Faculty Pension Plan ("the Plan"), to serve on the Board of Trustees for a four-year period from January 1, 2024 to December 31, 2027. UBC Elections has been tasked with the duty of holding the election on behalf of the Plan. If you wish to submit a nomination, please follow the instructions below.

#### **REQUIREMENTS FOR NOMINATION**

- **Completed Nomination Form**: Each nomination form must include <u>the name of the nominee</u> and the <u>identifiable signatures of three (3) nominators</u>. The nominee and nominators <u>must</u> be members of the Plan. The nominee must sign and indicate on the nomination form that they have read the description of the "Role and Responsibilities of a Trustee" (below) and are willing to run for election and abide by such rules established by UBC Elections for the conduct of the election. The election rules can be viewed at <u>https://senate.ubc.ca/council/rules/nongoverning</u>.
- **Candidate Statement**: Each nominee must provide a candidate statement of no more than 300 words, which will accompany election ballots and be posted on the election website to inform voters about the candidates' comparative qualifications to serve as a trustee. Please note that inclusion of hyperlinks in candidate statements is not allowed.

#### **ELECTION PROCESS**

Should an election prove necessary, election packages will be emailed or mailed to all Plan members on Wednesday, October 25, 2023.

#### **ROLE AND RESPONSIBILITIES OF A TRUSTEE**

A trust is a legal relationship whereby a trustee is responsible for administering property on behalf of the beneficiaries of the trust. All individual trustees are personally responsible to administer the pension plan in the best interests of the members. The legal obligations and responsibilities of pension trustees are extensive, and come from common law, the BC *Pension Benefits Standards Act* (PBSA) and other statutes. Under the PBSA all trustees on a board of trustees must:

- Act honestly, in good faith and in the best interests of the members and others entitled to benefits; and
- Exercise the care, diligence and skill that a person of ordinary prudence would exercise when dealing with the property of another person.

Trustees must not knowingly allow their own personal interests to conflict with their duties and powers in respect of the pension plan. Pension plan investments and financial decisions must be made in the best financial interests of plan members, and other persons entitled to benefits under the plan.
